Further, please note that furnishing false information, deliberate suppression of information or using unfair means at any stage of exam will render the candidate disqualified and he/she will be debarred from appearing in any selection or appointment in Railway or to other Government services and if appointed, the service of such candidate is liable to be terminated in future.

The candidates need to attend Medical Examination after Document Verification duly paying Rs.24/- towards medical examination fee. The date, time & place of Medical Examination will be intimated at the time of DV. Please note that you should be prepared to stay for than 3 to 4 days for DV/Medical examination at your own cost.

Request for change of schedule date i.e 09.10.2019 assigned to the absentee candidates will not be entertained. A candidate who does not attend for the document verification on 09.10.2019 will forfeit their candidature for any post of CEN 02/2019.
