CEN 03/2019 (Ministerial & Isolated Categories) Shortlisting of Candidates for Document Verification

- 1.0 Based on their performance in the Computer Based Test (CBT) conducted from 15.12.2020 to 18.12.2020 & on 07.01.2021 and Stenography Skill Test/Translation Test (as applicable) on 29th & 30th Oct 2021 by Railway Recruitment Board, Secunderabad for various posts under CEN 03/2019 and options furnished in their online applications, candidates bearing the following roll numbers have been provisionally shortlisted for Document Verification (DV) and Medical Examination.
- 2.0 The result for various categories has been prepared based on the principles/process laid down in para 13.0 of Detailed CEN.
- 3.0 Normalisation of raw marks has not been done since CBT exam for concerned category was conducted in a single shift only. No normalisation is applicable for Stenography Skill Test/Translation Test.
- 4.0 Candidates equal to the number of notified vacancies, subject to availability of eligible candidates, have been shortlisted for Document Verification (DV) and Medical Examination.
- 5.0 In case of two or more candidates securing the same marks, their merit position has been determined by age criteria i.e., older person has been placed at higher merit and in case of age also being same, then alphabetical order (A to Z) of names has been taken into account to break the tie.
- 6.0 If a candidate has applied for and appeared in more than one category consisting of a distinct question paper, based on his/her eligibility and post preference, he/she has been shortlisted accordingly for multiple categories as per his/her merit.
- 7.0 Shortlisted candidates will be informed through official websites/SMS/Email (provided in their application) about the date and place of Document Verification.
- 8.0 Candidates called for DV must produce all their original documents along with two sets of photocopies in A4 size as detailed in the CEN and e-call letter issued for Document Verification.
- 9.0 Candidates called for Document Verification must note that after completion of DV, they will be sent for medical examination at the nominated Railway Hospital on the next day. The candidates are required to come prepared to stay for additional days accordingly. Candidates will have to pay the prescribed medical fee of Rs 24/- only. There are no other charges to be paid to the Hospitals/Health Unit for the medical examination. In rare cases, where investigations like CT Scan, Ultra Sound tests (to rule out refractive eye surgery etc) have to be carried out for which necessary facility is not available in the Railway Hospital/Health Unit, then for such investigation, candidates may have to make the requisite payment to the concerned laboratory/hospital.
- 10.0 The candidature of all the shortlisted candidates is provisional and is liable to be cancelled at any stage of the recruitment or thereafter, in case of any inconsistency/ deficiency/ discrepancy in the information furnished by them in their online application or for any malpractice at any stage of the recruitment process or thereafter.
- 11.0 Candidates must note that mere shortlisting or call for Document Verification/Medical Examination does not entitle them in any way to an appointment in the Railways.
- 12.0 While every care has been taken in preparing the result, RRB reserves the right to rectify any inadvertent error or typographical/printing mistake etc. RRB regrets the inability to entertain any correspondence on this account.

NOTE: Beware of touts/unscrupulous persons offering appointments to candidates through illegal means. Any such involvement will lead to summary disqualification of the candidate and criminal prosecution. The recruitment process in RRB exams is based only on the merit of candidates.
