Instructions

1. While coming for Document Verification (DV) you must bring the following original certificates / documents (as applicable in your case) with you along with the e-call letter: -
 - i. Matriculation / High School Examination certificate or equivalent Certificate as proof of Date of Birth and Matriculation qualification. (Candidate's name and the father's /mother's name mentioned in the application will be verified with reference to the names mentioned in this certificate).
 - ii. 10+2 / Inter / Higher Secondary / PUC (as applicable)
 - iii. Professional Diploma / NTC / Degree Certificate with Semester wise Mark sheets
 - iv. Internship / Training / Experience certificates (as applicable in compliance with the minimum educational qualifications prescribed for the post).
 - v. Professional Registration certificates
 - vi. The educational qualification certificates viz., provisional or Regular Degree / Diploma /HSC (10+2) should contain the date of issue. In case, date of issue of these certificates is after the closing date of Notification, then the consolidated marks sheet with date of declaration of the final qualifying exam or individual marks sheets of all the semesters with date of declaration of each semester results should be submitted. In case of non-availability of date in any of these certificates, then a certificate indicating date of declaration of result from the Technical Board/ Council (NCVT/SCVT) / University to this effect should be produced at the time of DV.
 - vii. **SIX (6) passport size colour photographs NOT MORE THAN ONE MONTH OLD.**
 - viii. **SC / ST certificate** in the format as per **Annexure-I of CEN 02/2019.**
 - ix. Valid **OBC-NCL certificate** in the format as per **Annexure-II of CEN 02/2019.**
 - x. **Non-creamy layer declaration** by **OBC** candidates as per **Annexure –IIA of CEN 02/2019.**
 - xi. **Income certificate and Asset Certificate** by **EWS** candidates as per **Annexure-III of CEN 02/2019.**
 - xii. **Income certificate for waiving examination fees for Economically Backward classes** as per **Annexure IIIA of CEN 02/2019 / BPL Card /Izzat MST.**
 - xiii. Original Discharge Certificate, Ex Servicemen book, Identity card for Ex-Serviceman clearly mentioning the reason of discharge and other details.
 - xiv. For Ex Servicemen candidates who secured Civil employment after applying for this CEN, the acknowledged copy of the Self Declaration submitted to the Civil Employer giving details of application against this CEN along with NOC **as per Annexure -VII**
 - xv. Medical Certificate for Persons with Disabilities (PwBD) as per **Annexures V(A), V(B), V(C) of CEN 02/2019**
 - xvi. No Objection Certificate (NOC) for Serving Employees with their Date of Appointment.
 - xvii. No Objection Certificate (NOC) from Serving Defense Personnel with probable date of discharge
 - xviii. Minority Community Declaration on Non-Judicial Stamp paper as per **Annexure – IV of CEN02/2019.**
 - xix. Gazette Notification and/or any legal document in case of formal change of name as mentioned in **para 1.7 of General Instructions of CEN 02/2019.**
 - xx. **J&K Domicile Certificate.**
 - xxi. Certificate of eligibility from Government of India as per para **4(i)(f) of CEN 02/2019** on Nationality (For candidates other than citizen of India).
 - xxii. Decree of Divorce/Judicial separation from the Competent Court of Law as applicable in case of divorcee/judicially separated women and affidavit stating that the candidate has not remarried.
 - xxiii. Death certificate of spouse in case of widow candidates and affidavit stating that the candidate has not remarried.
 - xxiv. In case of variation in spelling in name, fathers name in the on-line application and original certificates / documents, candidates are required to submit relevant affidavit executed before Magistrate or Notary on required stamp papers stating that the referred person in certificate(s) is one & same on the date of verification.
 - xxv. Any other relevant certificate /testimonials/documents available with the candidate.
 - xxvi. The candidate should also bring **two (2) sets of clear & legible self-attested photocopies** each of the original certificates / documents mentioned above against (i) to (xxv). (As applicable)
 - xxvii. Aadhar card / e-Aadhar card.

2. If you fail to produce the above-mentioned original certificates on the date of document verification, your candidature is liable to be rejected and no further correspondence will be entertained in the matter. Further, please note that furnishing false information, deliberate suppression of information or using unfair means at any stage of exam will render the candidate disqualified and he/she will be debarred from appearing in any selection or appointment in Railway or to other Government services and if appointed, the service of such candidate is liable to be terminated in future.
3. Your candidature for above mentioned post(s) is purely provisional and subject to your fulfilling eligibility criteria in all respects.
4. It may be noted that merely calling a candidate for Document Verification & Medical Examination does not in any way entitle him/her to an appointment in Railways. Please note that your empanelment will be subject to correctness of all the information submitted by you in your on-line application, CBT and verification of documents.
5. **The candidates need to attend Medical Examination after Document Verification duly paying Rs.24/- towards medical examination fee. The date, time & place of Medical Examination will be intimated at the time of DV. Please note that you should be prepared to stay for than 3 to 4 days for DV/Medical examination at your own cost.**
6. The reason for failure to report on the regular document verification shall be supported by documentary evidence like sickness / university exams etc.
7. **(a) Reserve Date for verification of original documents for Absentee candidates: 09.10.2019**
For the candidates who fail to report for the document verification on the regular dates assigned to them in their e-Call Letter, a second and final chance to attend the Document verification is on 09.10.2019. No fresh e-Call Letter will be sent for this purpose and the candidates can attend with the same e-Call letter uploaded for the regular document verification. Only an SMS & EMAIL will be sent to the Mobile number and the email Id given in the online Application.

(b)The reason for failure to report in the regular document verification should be supported by documentary evidence that the candidate appeared in a University/Govt. examination or due to his/her personal sickness. No other reason for absence will be considered.

Requests for change in Block Date will not be entertained. Candidates absent even on the Block Date will forfeit their candidature for any post of CEN-02/2019.

8. Request for change of reserve date assigned to the absentee candidates will not be entertained. Candidates who does not attend for the document verification on the reserve date i.e., on 09.10.2019 will forfeit their candidature for any post of CEN 02/2019

Note :Candidates are advised to visit official website of RRB/Secunderabad regularly for the updates.
