- ☞ In terms of instructions contained in Railway Board letter no.99/E (RRB) 25/2 dated 18.03.1999, the **original certificates** of all the selected candidates should **again be thoroughly verified by the Personnel Branch before giving Appointment letters**. This may kindly be arranged. Wherever there is slight variation in name of the candidates/ father name available in the application when compared to their certificates of date of birth, qualification and also caste certificate, an affidavit/undertaking may be taken from the candidate by the concerned appointing authorities i.e. Sr. DPO, WPO. Such cases need not be referred to RRB for clarification.
- ☞ As per letter no. 2016-E(SCT)I/31/1 dated 23.06.2016 Railway Board has issued special instructions and detailed procedure as to how to deal about SC, ST, OBC candidates who are producing provisional/incomplete caste certificate. This may be communicated to all appointing authorities like Sr. DPO, WPO etc. for strict compliance.
- ☞ Offer of appointment will be issued by the **concerned officer of personnel department of the allotted unit (like division / Workshop etc.) or any other officer authorized** by Chief Personnel Officer, South Central Railway, Secunderabad, in the strict order of merit subject to fulfilling all the conditions stipulated in Railway Board's secret letter No. E(DA)78GS4-1 dated 21.04.1983 and all other conditions of the Administration issued from time to time.
