- Offer of appointment will be issued by the concerned officer of personnel department of the allotted unit (like division / Workshop etc.) or any other officer authorized by Chief Personnel Officer, South Central Railway, Secunderabad, in the strict order of merit subject to fulfilling all the conditions stipulated in Railway Board's secret letter No. E(DA)78GS4-1 dated 21.04.1983 and all other conditions of the Administration issued from time to time.
