**\*41 SCR UR standby candidates:** 41 UR (SCR-41, ECoR-0) standby candidates will be considered for SCR only as and when required but not for ECoR because 50% standby quota in UR community for ECoR has already been utilized.

**\*67 SC standby candidates:** 67 SC (SCR-45, ECoR-22) standby candidates will be considered for either SCR/ECoR as per their preference, subject to availability of vacancies as and when required in future.

**\*84 OB standby candidates:** 84 OB (SCR-46, ECoR-38) standby candidates will be considered for either SCR/ECoR as per their preference, subject to availability of vacancies as and when required in future.

4. Offer of appointment will be made by the concerned Railways Chief Personnel Officer, if found otherwise suitable, including medical examination as per rules.
