  Railway Recruitment Board, South Lallaguda, behind IRISET Complex, Secunderabad 500 017 (Telangana). The
  candidate will be informed via email and SMS to download their e-call-letter with further details and instructions.
- NOTE: Immediately after completion of DV, If found Suitable he will be sent for medical examination to nominated Railway Hospitals which will also involve extra travel. Candidate is therefore advised to come prepared accordingly.
- 4. The candidate must produce all his relevant documents as indicated in CEN 01/2018 (in Original)during DV along with two sets of photocopies (in A4 size as detailed in the CEN and e-call letter).
- 5. If the candidate fails again to attend the DV on the above date, his candidature will be cancelled and no further opportunity will be afforded. Candidate attending for document verification for Second and Final opportunity should ensure to produce all the required original certificates etc and along with photo copies. If he fails to produce any of them, no additional time will be given further and his candidature is liable to be rejected by RRB/SC.
- 6. It may be noted that merely calling a candidate for Document Verification does not entitle him in any way to an appointment in the Railways. The candidature of the candidate is provisional and is liable to be cancelled at any stage of recruitment or thereafter, in case of any discrepancy, inconsistency or deficiency in the data furnished by him or any malpractice on his part at any stage of the recruitment process.
