Based on the performance in the written examination conducted on 15.06.2014, 29.06.2014, 13.07.2014 and 20.07.2014 and also due to Absenteeism /Rejections during document verification held in the month of June/July-2016 and February-2017, following are the roll numbers of the candidates, who are also provisionally qualified to attend **document verification to be held on 04.12.2017** at office of Railway Recruitment Board, Secunderabad, for the post of **Technicians (all departments), of C.E.N. No. 01/2014.**
2. Results can also be seen on website <http://rrbsecunderabad.nic.in>, and **separate call letters are being issued by post** to attend document verification. However, eligible candidates can attend for document verification even if they do not receive call letter **on any working day between 10.00 Hrs to 17.00 Hrs on or before 04.12.2017.** Request for change of date and time for document verification will not be entertained.
3. Eligible candidates who are attending for document verification, have to produce certificates of the prescribed qualification for the post selected, **failing which their candidature will be rejected** for all categories of CEN 01/2014 and also their candidature will not be considered even for those categories with lower preference.
4. Information of result process with detailed procedure being followed for post allotment for various categories had already been uploaded in website vide letter No. RRB/SC/607/01/01/2014(CEN) dated 08.01.2016.
5. Candidates are required to produce for verification **the following original certificates/ documents** in support of their candidature (as applicable).
 - (i) Matriculation/High School Examination Certificate or Equivalent certificate (Proof for Date of Birth and Matric Qualification).
 - (ii) NCVT/SCVT/ Diploma Certificate (As applicable).
 - (iii) Caste Certificate for SC/ST - Annexure-3.
 - (iv) Caste Certificate for OBC - Annexure-4.
 - (v) Income Certificate for Waiving Examination Fee - Annexure-7.
 - (vi) Medical Certificate for Persons with Disabilities (PWD) - Annexure-9.
 - (vii) NOC from serving employees/Ex-Servicemen.
 - (viii) Minority declaration on Non-judicial Stamp Paper.
 - (xi) **Two recent passport size colour photographs.**
 - (x) **Two sets of attested copies of all original certificates.**

6. Candidates, who are already **servng employees** in any central / State Government Department including Railways or public sector undertakings, are required to produce **No Objection Certificate (NOC)** from the employer during document verification without fail.
Note: Candidates should note that in case a communication is received from their employer by the RRB concerned withholding permission to the candidates applying for/ appearing at the examination, their candidature is liable to be rejected / cancelled.
7. Candidates applying against **reserved vacancies (SC/ST/OBC)** and/ or seeking age relaxation must submit requisite caste certificate in the prescribed format from the competent authority (The Certificates, as applicable should be submitted during document verification). Otherwise, their **claim for reserved status (SC/ST/OBC) will not be entertained** and the candidature of such candidates, if fulfilling all the eligibility conditions for General (Un-reserved) category, will be considered under General (UR) vacancy only.
8. While every care has been taken in preparing the results, the Railway Recruitment Board, Secunderabad, **reserves the right to rectify the errors & omissions**, at any stage if any.
9. The result is purely provisional and in case **if any candidate is found to have been debarred** by any of the RRBs, his/her **candidature will be cancelled and liable to be removed from service** at any later stage.
