The Computer Based Test (CBT-1) for the various Posts of Assistant Loco Pilot (ALP) categories against CEN NO: 01/2025 was conducted from **13-02-2026 to 18-02-2026 & 11-03-2026**. In order to enable candidates who appeared in the CBT-1 to view their questions, responses and answer keys, a link has been provided on the websites of RRBs which will be active from **20.03.2026 at 17:00 hrs. to 26.03.2026 upto 17:00 hrs.**

After viewing the details as above, objections if any regarding the questions, options and answer keys can be raised by the candidates for which the time schedule, fee and procedure is given below:

1. TIME SCHEDULE:

1.	Viewing of Questions, Responses, Answer Keys and Raising of objections against the Questions, Options and Answer Keys and online fee payment.	20.03.2026 at 17:00 hrs onwards
2.	Closing of viewing of Questions, Responses, Answer Keys and Raising of objections against the Questions, Options and Answer Keys and online fee payment.	26.03.2026 upto 17:00 hrs

2. FEE FOR RAISING OBJECTIONS:

The prescribed fee for raising **objection is Rs.50/- plus applicable Bank Service Charges per question**. In case the objection raised is found to be correct, the Fee Paid against such valid objections shall be refunded to the candidate after deduction of applicable Bank charges. The refund will be made to the account from which the candidate has made the online payment.

3. MODE OF PAYMENT OF FEE:

- Maestro, Master Card, VISA, Rupay Cards – both Debit Cards & Credit Cards of all major banks.
- UPI/ UPI QR Codes.
- Net Banking/ Mobile Banking

4. PROCEDURE FOR RAISING OBJECTIONS:

The detailed procedure with necessary guidelines will be available in the link provided on the official websites of RRBs.

- Candidates are advised to raise objection(s), if any, well before the final date and time i.e. **26.03.2026 at 17:00 hrs** after which no representation from the candidates on the questions, options, keys etc. will be entertained.
- The decision of RRBs on the objections raised shall be final and binding and no further correspondence shall be entertained from the candidates in the matter.
