1. Candidates are advised to upload clear & legible scanned images of all the documents, scanned copy of their passport size color photograph (as uploaded in their Online Application) and scanned image of complete signature in RRB Document verification Portal <https://oirms-ir.gov.in/rrbdv/> duly following the instructions mentioned therein. This portal will be active for uploading requisite document 10 days before your DV date to till your DV date.
2. The Document Verification (DV) will be held from **27.07.2026 to 29.07.2026 (Reporting Time: 09.30 hours & 13:30 hours)** as per the above schedule at Railway Recruitment Board, South Lallaguda, behind IRISSET Complex, Secunderabad – 500 017 (Telangana).
3. Candidates are advised to bring all the required documents at the time of Document Verification(DV) – as mentioned below:
 - i) Original Certificates as listed in item No.2 of instructions in the E-call-letter along with 2 (two)sets of clear & legible photocopies (in A4 size).
 - ii) 3 Current passport size photographs.
 - iii) **03 Current stamp size passport size photographs.**
 - iv) **Candidates must also bring a copy of the SAME color passport photograph which was uploaded in their online application during DV/ME.**
 - v) **Upper portion of E-call letter** of CBT.
 - vi) Photo copy of both sides of **Aadhaar card**.
 - vii) Medical examination fee of **Rs.24/- (in cash)** to be paid at RRB.
 - viii) **Candidate must indicate in the RRB Document Verification portal at least two clearly visible identification marks on their face / body, well in advance, for entry in their medical memo. These marks shall be same as indicated in application form. Incase, no/single mark indicated in application form, he/she must add balance indication marks in the OIRMS.**
4. Certificates produced during the DV should be in prescribed format and either in English or Hindi. Further, no additional time will be given to the candidates for not producing their original certificates on the date of DV. Candidates absent during the DV/Block Date DV and/or medical examination will forfeit their candidature.
5. Candidates initially found suitable in the DV will have to undergo Medical Examination (ME) at nominated Railway hospitals. This may also involve extra travel and stay from RRB to the city of the Railway Hospital. Accordingly, candidates must come prepared for DV and Medical examination for more than 3 to 4 days.
6. Candidates can download their DV e-call letters along with the travel authority (as applicable) from the website of RRB/Secunderabad using the under-mentioned link:

IMPORTANT: Candidates must upload their (i) passport size photo, (ii) scanned signature and (iii) two marks of identification marks (not scars/cut marks), in the RRB Document Verification portal <https://oirms-ir.gov.in/rrbdv/> as per instructions mentioned therein. This portal will be active for uploading documents from **17.07.2026** till the date of DV.

7. Please read the detailed instructions given in the DV e-call letter carefully and bring all the required certificates/documents **in ORIGINAL and Two Sets of PHOTOCOPIES** (in A4 size) for Document Verification (DV).
8. Candidates will be informed via registered email id to download their e-call-letters and travel passes (as applicable) which will be made live one week before the scheduled date of Document verification.
9. The **Block dates** for Document verification in case the candidates are absent on scheduled date of Additional Document Verification is **10.08.2026**

- Note: a)** If a candidate does not attend the DV on the scheduled date or on the Block date, his/her candidature will be cancelled for all opted posts against the CEN 02/2024 Technician Grade-III and no further opportunity will be afforded under any circumstances.
- b)** Roll No. wise Schedule for Block date DV will be published in the RRB, Secunderabad website.
Hence candidates are advised to strictly follow the DV schedule. No separate DV call letter will be issued for this purpose.
