- Candidates are advised to upload clear & legible scanned images of all the documents, scanned copy of their passport size color photograph (as uploaded in their Online Application) and scanned image of signature in RRB Document verification Portal <https://oirms-ir.gov.in/rrbdv/> duly following the instructions mentioned therein. This portal will be active for uploading 10 days before your DV date to till your DV date.
- The Document Verification (DV) will be held on **29.07.2026 (Reporting Time: 13:30 hours)** at Railway Recruitment Board, South Lallaguda, behind IRISSET Complex, Secunderabad – 500 017 (Telangana).
- Candidates are advised to bring all the required documents at the time of Document Verification (DV) as mentioned below:
 - Original Certificates as listed in item No.2 of instructions in the E-call-letter along with 2(Two) sets of clear & legible photocopies (in A4 size).
 - 3 current passport size photographs.
 - 3 current stamp size passport size photographs.
 - Candidates must also bring a copy of the SAME color passport photograph which was uploaded in their online application during DV/ME.
 - Upper portion of E-call letter of CBT/CBST (As applicable)
 - Photocopy of both sides of Aadhaar card.
 - Receipt of payment If made through challan at bank or post office.
 - Medical examination fee of **Rs.24/- (in cash)** to be paid at RRB.
- Candidate must indicate at least two clearly visible identification marks on their face / body (as available in 10th class certificate/ filled by you in the application), well in advance, for entry in their medical memo. Cut marks and scar marks shall not be allowed.
- Certificates produced during the DV should be in prescribed format and either in English or Hindi. Further, no additional time will be given to the candidates for not producing their original certificates on the date of DV. Candidates absent during the DV and/or medical examination will forfeit their candidature.
- Candidates initially found suitable in the DV will have to undergo Medical Examination (ME) at nominated Railway hospitals. This may also involve extra travel and stay from RRB to the city of the Railway Hospital. Accordingly, candidates must come prepared for DV and Medical examination for more than 4 to 5 days.

8. **IMPORTANT:** Candidates must upload their (i) passport size photo, (ii) scanned signature as signed in the online application and (iii) two visible marks of identification (Cut marks and scar marks shall not be allowed), in the RRB Document Verification portal - <https://oirms-ir.gov.in/rrbdv/> as per instructions mentioned therein. This portal will be active for uploading documents from **19.07.2026** till the date of DV.
9. Please read the detailed instructions given in the DV e-call letter carefully and bring all the required certificates/documents **in ORIGINAL and Two Sets of PHOTOCOPIES** (in A4 size) for Document Verification (DV).
10. Candidates will be informed via registered email to download their e-call-letters and travel passes (as applicable) which will be made live one week before the scheduled date of Document verification.
11. The **Block date** for Document verification in case the candidates are absent on scheduled date of DV is on **10.08.2026 (Monday) at 09:30 hrs.**
Note: If a candidate does not attend any one of the scheduled /Block date DV, his/her candidature will be cancelled and no further opportunity will be afforded. RRB regrets inability to entertain any correspondence from unsuccessful candidates.
